

INSTRUCTION OF THE CONSUMER

§1 cancellation legal

You can revoke your contract explanation by return of the thing within 14 days, or what, without detail of reasons in text form (e.g. letter, fax, e-mail), if the thing in front of expiration of time is left to you. The period starts upon receipt of this instruction in text form, not in front of however receipt of the product with the receiver (on the recurring delivery of uniform goods not in front of receipt of the first partial delivery) and neither before fulfilment of our obligations to disclose information in accordance with article 246 § 2 in connection with § 1 para. 1 and 2 Introductory Law to the German Civil Code as well as our duties in accordance with § 312e para. 1 set of 1 BGB in connection with article 246 § 3, Introductory Law to the German Civil Code. For the preservation of the revocation period the punctual despatch of the revocation or the thing suffices.

§2 cancellation results

In the case of an effective revocation the performances received on both sides have to be granted and uses (e.g. interest) drawn if necessary to be returned back. If you can not or only in deteriorated condition completely or partly grant back us the received performance, you must do us equivalent compensation in this respect if necessary. This does not apply to the cession of things if the deterioration of the thing can be explained by the examination as it would have been possible approximately in the retail shop for you exclusively. You can avoid the duty to the equivalent compensation as for the rest for a deterioration arisen the taking into use according to the regulation of the thing by not taking the thing like your property in use and refraining from everything whose value impairs. Package dispatch capable things have to be returned on our risk. You have to bear the costs of the return, if these ordered this one delivered goods corresponds and if the price of the thing to be returned does not exceed an amount of 40 euros or if you have not produced the service in return or a partial payment agreed on by contract at a higher price of the thing at the time of the revocation yet. The return otherwise is cost-free for you. Not package dispatch capable things are collected from you. Obligations to the refund of payments must be met within 30 days. The period starts with the despatch of your revocation explanation or the thing, for us with the reception for you.

§3 special tips

The cancellation legal does not exist with distant sales contracts for the delivery of audio recordings or video recordings or from software, provided that the delivered data carriers have been unsealed by the consumer.
